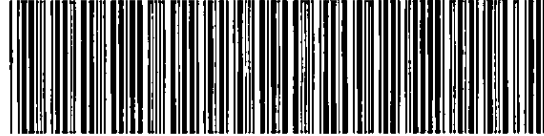

**ARTICLES OF INCORPORATION

Initial Board of Directors


