

ARTICLES OF INCORPORATION

OF

JAMES A. DOWNEY, MD, PA A FLORIDA PROFESSIONAL ASSOCIATION

Pursuant to the provisions of Chapter 607 and Chapter 621, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida professional association:

ARTICLE I - NAME

The name of this professional association is as follows:

James A. Downey, MD, PA

(hereinafter referred to as the "Corporation)

ARTICLE II - INITIAL PRINCIPAL OFFICE

The initial principal place of business of the Corporation is as follows:

ARTICLE III - DURATION

The Corporation is to commence its corporate existence on the date of filing by the Secretary of the State of Florida.

This Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

This Corporation is organized for the following purposes:

- (a) To own and to operate a pediatric medical practice; and
- (b) The transaction of any and all other lawful business for which professional service corporations may be incorporated, including but not limited to those powers pursuant to Chapter 607 and Chapter 621, Florida Statutes, as amended, and the doing of all lawful things related thereto.

ARTICLE V - LICENSED SHAREHOLDERS AND OFFICERS

who accepts employment that places restrictions or limitations
upon his or her rendering of professional services for the

Corporation, shall sever all employment with, and financial interest in, the Corporation.

ARTICLE VI - CAPITAL STOCK

This Corporation is authorized to issue Ten Thousand (10,000) shares of One and NO/100 Dollars (\$1.00) par value common stock. Each outstanding share, regardless of class, shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the Shareholders, unless otherwise designated as "NONVOTING" by a resolution recorded in the Corporate Minute Book and a similar legend on the subject certificate(s). The shares of stock may be issued for such consideration as determined from time to time by the Board of Directors. Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.

ARTICLE VII - INITIAL REGISTERED AGENT AND OFFICE
