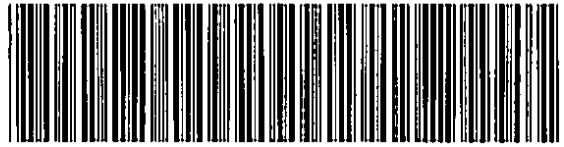


**ARTICLE XI**
