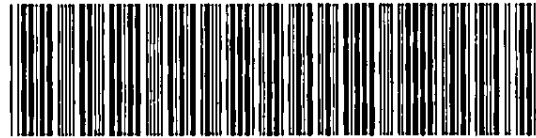

**PLAN OF CONVERSION
TO
FLORIDA PROFIT CORPORATION**

THIS PLAN OF CONVERSION (this "Plan") is hereby adopted this 30th day of July, 2020, by ThinkSync Solutions LLC, a Florida limited liability company (the "Company").

RECITALS

WHEREAS, the Company is a Florida limited liability company, formed May 29, 2020; and

WHEREAS, the Company desires to convert the Company to ThinkSync Solutions Inc., a Florida Profit Corporation ("ThinkSync Solutions Inc.").

NOW THEREFORE, the Company hereby adopts the following:

1. The Company hereby approves the conversion of the Company to ThinkSync Solutions Inc. (the "Conversion").
2. The Company intends the Company to continue its existence as a Florida Profit Corporation after its conversion to ThinkSync Solutions Inc.
3. The Company's percentage interest shall be distributed as follows:
 - 27% ownership to Dustin Grzegorzewski
 - 25% ownership to Chase Matheson
 - 48% to be converted to issuable shares
