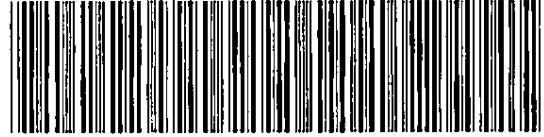

Adoption of Amendment

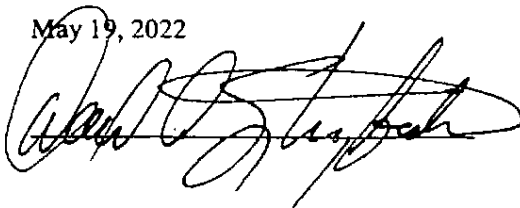
The Amendment was adopted on May 19, 2022 by the Board of Directors and by the shareholders. The number of votes cast for the Amendment was sufficient for approval.
