**ARTICLES OF INCORPORATION

Article I - Name

The name of this Corporation is **LA IN CUBA DORA INC.**

Article II - Purpose



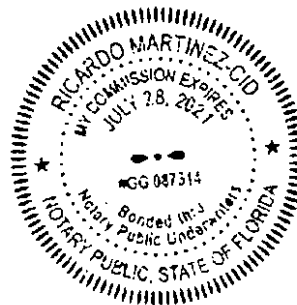


