**ARTICLES OF INCORPORATION
OF
FL DENTAL PROFESSIONALS P.A.**

In compliance with the requirements of the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be FL Dental Professionals P.A. (the "**Corporation**").

ARTICLE II: INITIAL PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Corporation is 5710 North Davis Hwy., Suite 1, Pensacola, FL 32503.

ARTICLE III: PURPOSE

The Corporation is organized to provide professional dental services.

ARTICLE IV: SHARES

The total number of shares that the Corporation is authorized to issue and have outstanding at any time is One Thousand (1,000), all of which shall be common stock with a par value of \$0.01 per share.




