ARTICLES OF INCORPORATION OKE BAM HOLDINGS, INC.

Pursuant to the provisions of Section 607.0202 of the Florida Business Corporation Act, the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

ARTICLE I - NAME The name of the corporation is QKF BAM Holdings, Inc. ARTICLE II - ADDRESS The principal office and mailing address of the corporation is 7800 Red Road, Suite 308, Miami, Florida 33143.

ARTICLE MI - CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of common stock, par value \$0.01 per share.

The foregoing right of indemnification shall not be exclusive of any other rights to which any director, officer may be entitled as a matter of law or which he or she may be lawfully granted.
