**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of FIVE Enterprise FLA GP Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.


ARTICLE V. AUTHORIZED SHARES


