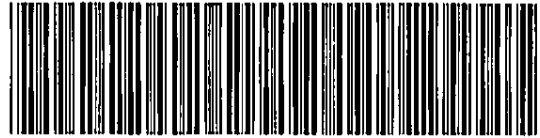




**SPECIAL AND REVOCABLE



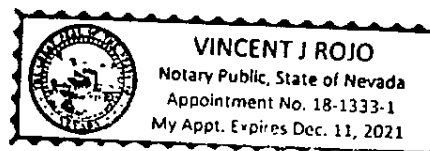
