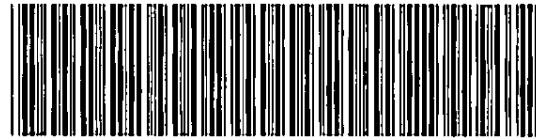



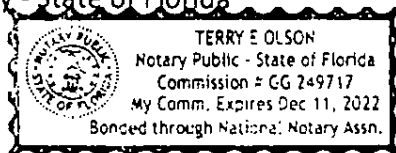
1. Introduction. Mark Westmoreland, being duly sworn, deposes and says:
