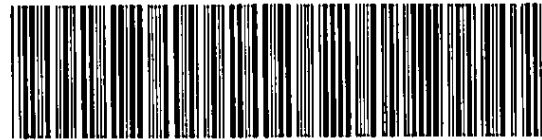

SHARE TRANSFER AGREEMENT

This Share Transfer Agreement (the "Agreement") is dated as of January 1, 2021 by and between Irene Sofia Marshall, and Gary M. Burnett.

WHEREAS, Irene Sofia Marshall owns 100% of the issued and outstanding shares of common stock of TMP Real Estate Corporation, a Florida Corporation; and
