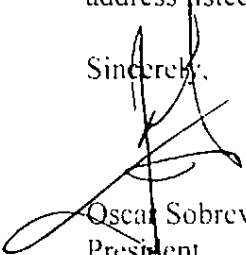

**ARTICLES OF INCORPORATION  
FOR  
FLORIDA PROFIT CORPORATION**

The undersigned certifies that I have associated myself for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of a corporation for profit. I further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the corporation:

**ARTICLE I – NAME OF THE CORPORATION**

The name of the corporation shall be:

**ARTICLE II – PRINCIPAL PLACE OF BUSINESS**

In addition to the powers authorized by the laws of the State of Florida for corporations, the general nature of the business or businesses to be transacted, and which the corporation is authorized to transact, shall be as follows:

1. To carry out the performance of building, remodeling, demolishing, and installing pools and pool related work and services.
2. To engage in any activity or business authorized under the Florida Statutes and carry on any and all incidental business without limitation.
3. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

4. To exercise all or any of the corporation powers, and to carry out all or any of the purposes, as listed in these Articles and otherwise granted or permitted by law.
5. Nothing contained in these Articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the corporation to carry on any business, exercise any power, or do any act which a corporation may not, under Florida laws, lawfully carry on, exercise, or do.

#### **ARTICLE IV – EXERCISE OF POWERS**

All corporation powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of the President of the corporation. This Article may be amended from time to time in the regulations of the corporation by the President of the corporation.

#### **ARTICLE V – SHARES**

The corporation's number of shares of stock is 500.

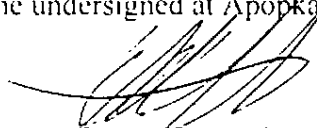
