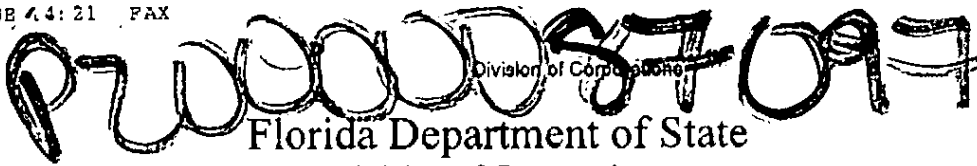

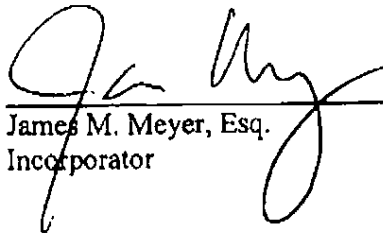
ARTICLE X. BYLAWS
