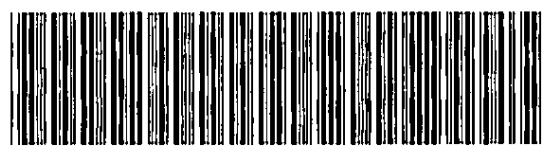

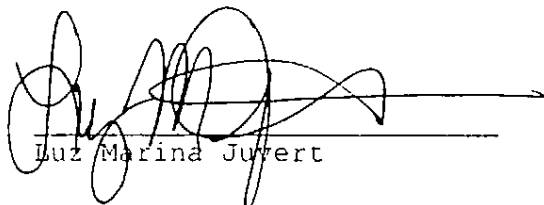

The undersigned, acting as incorporator of this corporation under the Florida general Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

Name of Corporation

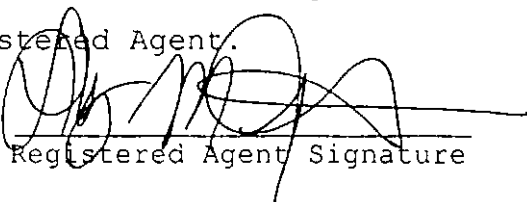

#### Term of Existence

The period of duration of the Corporation is perpetual unless dissolved according to law.

### ARTICLE IV

#### Purpose

There shall be a Board of Directors for this Corporation which shall consist of one (1) persons. The number of Directors may be increased or diminished from time to time as determined by the By-Laws, but shall never be less than one. Each of said Directors shall be of full age. Any director may be removed at any annual or special meeting of stockholders called in accordance with the By-Laws of the Corporation, by the same vote as the required to elect a Director.

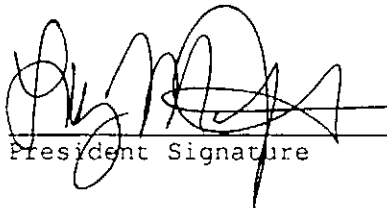

**Cumulative Voting**

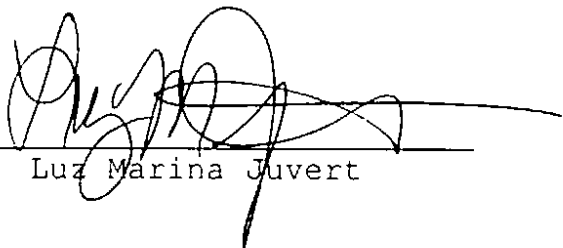

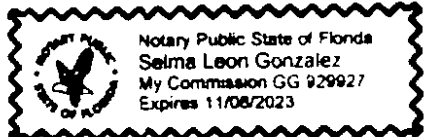

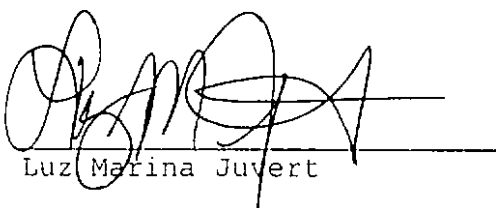
