ORDER ON MOTION FOR DEFAULT FINAL JUDGEMENT

THIS CAUSE having come before the Court on Plaintiff's Motion for Default Final Judgment Against Lemke Vision Inc. for Injunctive Relief ("Motion"), the Court having reviewed the relevant pleadings, reviewed the Affidavit of Mitchell Rothstein, attached hereto as Exhibit A, and otherwise being fully advised on the premises, the Court **HEREBY FINDS:**

Lemke Vision Inc., ("Lemke") purportedly was created and existed as a legal corporate entity as reflected on the Florida Secretary of State's records at Document Number: P20000091018. Lemke's only listed officer, and the registered agent, were shown as the same person, "Mitchell Roth-Stein" and using Plaintiff's actual address. As set forth in the attached affidavit, Plaintiff did not authorize anyone to use his name or address for the creation of Lemke. Plaintiff further believes Lemke was formed by persons unknown who intended to obtain credit using Plaintiff's information without his knowledge or permission and may have been utilized for other improper purposes.

Accordingly, the Court, having reviewed the Complaint and the relevant documents, and there being no response to the Complaint on behalf of Lemke, **HEREBY ORDERS:**

1. Plaintiff's Motion for Default Final Judgment is hereby **GRANTED** and judgment is entered in favor of Plaintiff, Mitchell Rothstein and against the Defendant, Lemke Vision Inc.
2. A **PERMANENT INJUNCTION** is **ENTERED** Against Lemke Vision, Inc. Further, Lemke Vision, Inc., is enjoined from, directly or indirectly, or in concurrent with any others, conducting business through, or using any of the personal identification information of Mitchell Rothstein for any reason. Lemke Vision Inc., and any persons purporting to act on behalf of Lemke Vision, Inc. are hereby enjoined from holding out, operating or transacting any business by, through, or in the name of Lemke Vision Inc.
3. The Florida Division of Corporations is directed to amend its records to either delete the entity, Lemke Vision Inc., Document Number: P20000091018, from its online records at www.sunbiz.org;, and, if that cannot be accomplished, to ensure this Order and the attached affidavit appear prominently on those records maintained by the Division related to Lemke Vision, Inc.

Before me, the undersigned authority, personally appeared Mitchell Rothstein, who being duly sworn states as follows:

1. My name is Mitchell Rothstein.
2. I am over the age of 18 and am otherwise competent to testify as to all matters set forth herein.
3. I make this affidavit based on my personal knowledge.
4. On or about January 19, 2021, I discovered that there was a fraudulent business created using my name and address.
5. The fraudulent business had an Electronic Articles of Incorporation for a business named Lemke Vision Inc. ("Lemke") Document Number: P20000091018, with the Florida Division of Corporations ("Sunbiz"). A true and correct copy of the print-out from sunbiz.org is attached hereto and incorporated by reference as Exhibit "A."

6. I did not file the registration for Lemke nor did I authorize anybody to register the business named Lemke on my behalf.

7. Regardless, my name and address is listed on the Articles of Incorporation for Lemke. A true and correct copy of the print-out from sunbiz.org is attached hereto and incorporated by reference as Exhibit "B."

8. Again, I did not authorize the registration of Lemke nor did I authorize my name to be listed on the Articles of Incorporation.

9. I know that the person who created Lemke fraudulently has further attempted to obtain credit in my name.


10. I want Lemke completely removed and deleted from the Florida Division of Corporations since it was registered with my stolen identity.

11. I am irreparably harmed and will continue to be irreparably harmed if the filing is not removed and also if Lemke is not enjoined from future use of my name, address, and identity.

12. I have no way of knowing whether anyone associated with Lemke will attempt to use my name and information to obtain loans, credit cards or otherwise on behalf of the entity.

13. Furthermore, I have no way of knowing if Lemke or anyone associated with Lemke is further using my identify for unlawful and fraudulent purposes.
