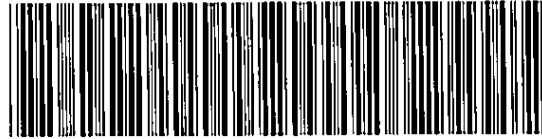

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation, in compliance with Chapter 607 and Chapter 621, Florida Statutes.

ARTICLE I

The name of the corporation shall be JAG & Company CPAs, P.A.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 1427 Piedmont Drive, E, Tallahassee, Florida 32308. This corporation shall exist perpetually.

ARTICLE III

The purpose for which this corporation is organized is:

To provide all forms of professional accounting services to include tax and financial statement preparation, bookkeeping, and management advisory services in the State of Florida. All shareholders are required to hold a Certified Public Accounts license and be authorized to provide accounting services in the State of Florida.




