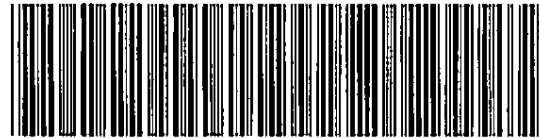

The name of this corporation is PURESCIENCE.COM, INC.

ARTICLE II. DURATION


