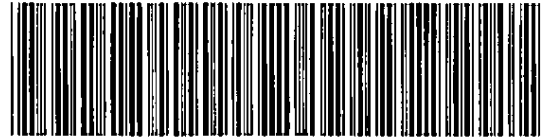

The undersigned, for the purpose of forming for-profit corporation under the law of the State of Florida, do hereby adopt the following Article of Incorporation.

Article I

Name

The name of the corporation shall be **Bullard's Technical Educational Training Services, Inc.** (hereinafter called the "Corporation")

Article II

PRINCIPAL OFFICE AND MAILING ADDRESS

Purpose

The Corporation is for profit a profit organized by the purpose of engaging in many lawful act or activity for which profit corporations may be organized, so far as is or may be permitted by the law of the state of Florida.
