## **INTERROGATORIES**

1. On June 9, 2021, Crowley Maritime Corporation, a Delaware Corporation, affiliated with a Delaware corporate entity Crowley Holdings, Inc., filed a Statement of Fact with the Division of Corporations. (See attached Exhibit A) The Statement of Fact asserts the address of 9487 Regency Square Boulevard, Jacksonville Florida, 32225, which was included in the Articles of Incorporation by the purported Florida corporate entity "Crowley Holdings, Inc" is exclusive to Crowley Maritime Corporation. Please provide the address for the Florida corporate entity "Crowley Holdings, Inc." that filed Articles of Incorporation on November 30, 2020. (See attached Exhibit B)

2. Exhibit A also asserts the inclusion of a Mr. Robert Grune as the Vice President is incorrect. Please provide an explanation for the use of Mr. Robert Grune as the Vice President for the Florida corporate entity of Crowley Holdings, Inc. and, given the denial of such authorization, provide revised Articles of Incorporation identifying proper corporate officers.

3. Why should the Florida corporate entity Crowley Holdings, Inc., not be dissolved for providing materially false information concerning its principals and address in its Articles of Incorporation filed November 30, 2020? (Exhibit B)

4. Did John Williams, the purported filer of the Articles of Incorporation on November 30, 2020, knowingly and willfully falsify or conceal a material fact, make any false, fictitious, or fraudulent statement or representation, or make or use any false document, knowing the same to contain any false, fictitious, or fraudulent statement or entry in its filing with the Department of State?

#### STATEMENT OF FACT

This Statement of Fact, dated June 9, 2021, is filed with the Florida Department of State, Division of Corporations (the "Division") to correct the corporate records of Crowley Holdings Inc., a Florida corporation (the "Corporation"). Document Number P20000093754. We request that this Statement of Fact be added to the corporate records of the Corporation as a matter of public notice.

The Division's sunbiz.org website reflects that on November 30, 2020 John Williams, as incorporator, filed Articles of Incorporation to incorporate the Corporation (the "Articles"). The Articles contain fraudulent and/or unauthorized information. First, the Articles identify "9487 REGENCY SQUARE BLVD, JACKSONVILLE, Fl. US 32225" as the Corporation's principal place of business and the address of the officers and incorporator of the Corporation. However, such address is exclusive to Crowley Maritime Corporation ("CMC") and such address was not, and is not, an address of the Corporation or the Corporation's officers or incorporator. While CMC is affiliated with Crowley Holdings, Inc., a Delaware corporation ("CHI"), neither CMC nor CHI have any affiliation with the Corporation. Second, the Articles identify Robert Grune ("Mr. Grune") as a Vice President of the Corporation. However, while Mr. Grune previously served as an officer of numerous subsidiaries of CHI, Mr. Grune was not, and is not, the Vice President of, or affiliated with, the Corporation and did not authorize the filing of the Articles. Finally, neither CMC nor CHI authorized the filing of the Articles.
