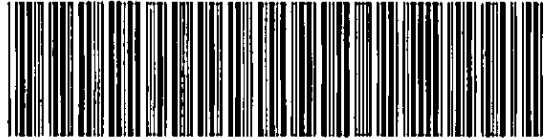

I am the principle of the Center of Sustainable Agroforestry, Inc. I have been in touch this week with Ms. Melanie Sellers in the Director's Office of the Ombudsman who helped me straighten a situation out.

The Center of Sustainable Agroforestry was filed as a not-for-profit at one point and we never operated as such. IRS 501(c)(3) designation was not obtained. I wish to release the application and I do not wish to reinstate the original filing. I do wish to maintain the same name for the new, for-profit-corporation. We have been paying the RT-6 tax right along as well as the Federal Taxes for at least 2 years. Our State Account # is 3563663.
