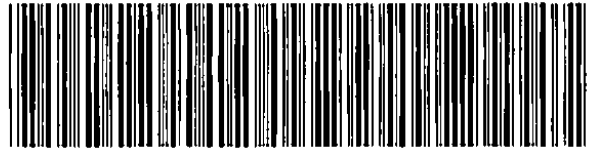

**ARTICLES OF INCORPORATION
OF
CMXI Corp.,
*a Florida benefit corporation***

ARTICLE I. NAME

The name of the corporation shall be **CMXI Corp.** (hereinafter also referred to as the "**Corporation**")

ARTICLE II. ADDRESS

The place in the state of Florida where the principal office of the Corporation is to be located is 1751 1st Ave N, St. Petersburg, FL 33713. The mailing address of the Corporation shall be the same as above listed.

ARTICLE III. DURATION AND COMMENCEMENT

The Corporation will exist perpetually, commencing with the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE IV. BENEFIT STATEMENT AND BUSINESS PURPOSE

The Corporation is established as a benefit corporation in accordance with s. 607.603, F.S. The purpose for which the corporation is organized is to: (a) engage in any and all lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act and (b) to promote positive effect, to create a public benefit and to inspire others in the community to prioritize the greater good as a normal practice. This will be accomplished through the production and deployment of mobile housing and facilities in areas of need, conscientious business practices and utilizing a portion of profit to support the communities we operate in.

ARTICLE V. SHARES

The number of authorized shares of the Corporation is 1,000.

ARTICLE VI. OFFICERS AND BOARD OF DIRECTORS

The Corporation shall be governed by its Board of Directors. The Corporation's bylaws shall specify the number of directors to serve. The name and address of the person who is the initial officer and director of the Corporation is as follows:

ARTICLE VII. LIABILITY LIMITATION

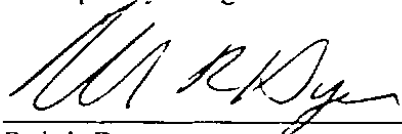

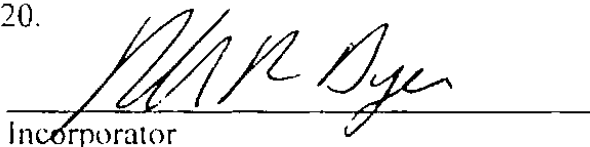
ARTICLE VIII. INCORPORATOR
