Certificate of Incorporation of SOVEREIGN SOCIETY ENTERPRISES, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 1,000,010,000 of which 1,000,000.000 shares of par value \$0.001 per share shall be designated as Common Stock and 10,000 shares of par value \$0.001 shall be designated as Preferred Stock. Shares of Preferred Stock may be issued in one or more series from time to time by the board of directors, and the board of directors is expressly authorized to fix by resolution the voting powers, designations, preferences, limitations, restrictions, relative rights and distinguishing designations of each series of Preferred Stock before the issuance of any shares of Preferred Stock in such series.
