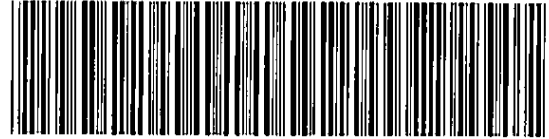

**ARTICLES OF INCORPORATION
OF
RICHFIELD ASSOCIATES FL, INC.**

ARTICLE I

The name of the corporation is **RICHFIELD ASSOCIATES FL, INC.** (hereinafter, the "Corporation").
