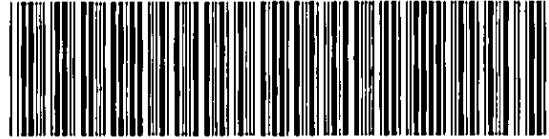

ARTICLES OF INCORPORATION

OF

A FLORIDA CORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida corporation for profit:

ARTICLE I - NAME

The name of this Corporation shall be as follows:

ARTICLE III - DURATION

The Corporation is to commence its corporate existence on **January 1, 2021**. This Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

This Corporation is organized for the following purposes:

Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.


present. These Articles of Incorporation shall not be amended or repealed without a meeting.


