**ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is: W.R.L. Transportation, Inc.. The principal office of the corporation is located at 7 Oakmont Drive, Rome, Georgia 30161.

ARTICLE II

This corporation is organized for the purpose of transacting any or all lawful business permitted under the Laws of the United States and of the State of Florida.

ARTICLE III

The total number of authorized shares of the capital stock of this corporation is One Thousand (1,000) shares, of a single class of voting common stock, all of which shall have a par value of One Dollar (1.00) each. Each issued and outstanding share of common stock shall be entitled to one vote.

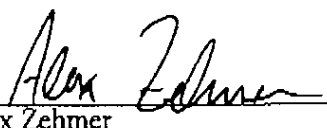

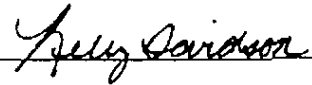
