ARTICLE I - NAME

The general purpose of the business to be transacted by this Corporation is:

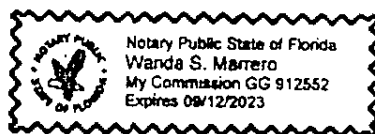
