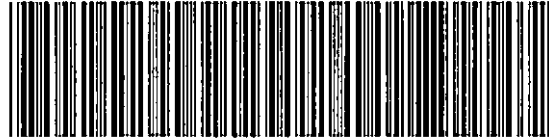

**ARTICLES OF INCORPORATION
OF
TAKE NO LOSSES, INC.**
(In compliance with Chapter 607 and/or Chapter 621, Florida Statutes)

ARTICLE I

The name of the Corporation ("Corporation") is "TAKE NO LOSSES, INC."

ARTICLE II

The street address of the principal office and mailing address of the Corporation is 6536 Beach Blvd. Apt.6, Jacksonville, FL 32216.

ARTICLE III

The corporation is formed for the specific purpose of providing music and entertainment including writing, recording, and performing original music scripts. The corporation may invest any funds in real estate, mortgages, stocks, bonds, or any other type of investment, and may own real and personal property necessary for the advancement of the corporation.

ARTICLE IV

The existence of the Corporation shall be perpetual and commence on September 1, 2020.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is Ten Thousand (10,000) shares of common stock having a par value of \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

directors may be increased from time to time, but in no event shall the number of Directors be less than one (1).

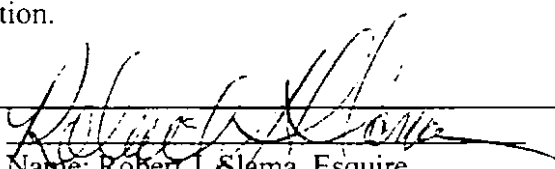
