ARTICLES OF INCORPORATION

OF

FINANCIAL 1 TAX, INC.

a Maryland close corporation

FIRST: The undersigned, Tatyana Bunich, whose address is 2519 Smith Avenue, Baltimore, MD 21209, being at least eighteen (18) years of age, does hereby form a corporation under the general laws of the State of Maryland.

SECOND: The name of the corporation (hereinafter called the "Corporation") is Financial 1 Tax, Inc.

THIRD: The Corporation shall be a close corporation as authorized by Title 4 of the Corporations and Associations Article of the Annotated Code of Maryland, as amended.

FOURTH: The purposes for which the Corporation are formed are as follows:

- (1) To engage in the tax return preparation and tax service business and other related or associated services, both in this state and in any part of the world.
- (2) To do anything permitted by the Corporations and Associations Article (Section 2-103) of the Maryland Code as amended from time-to-time.

FIFTH: The address of the principal office of the Corporation in Maryland is 2519 Smith Avenue, Baltimore, MD 21209. The name and address of the resident agent of the Corporation in Maryland is Tatyana Bunich, 2519 Smith Avenue, Baltimore, MD 21209. Said resident agent is a citizen of Maryland and actually resides therein.

SIXTH: The total number of shares of stock which the Corporation has authority to issue is two thousand five hundred (2,500) shares without par value all of one class.

SEVENTH: After the completion of the organizational meeting of the directors and the issuance of one or more shares of stock of the Corporation, the Corporation shall have no board of directors. Until such time, the Corporation shall have one (1) director, whose name is Tatyana Bunich.

EIGHTH: To the maximum extent that Maryland law in effect from time-to-time permits limitation of the liability of directors and officers, no director or officer of the Corporation shall be liable to the Corporation or its stockholders for money damages.
