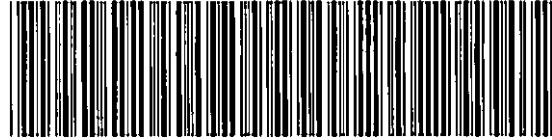


1. The name of the corporation is: **AEA Finance, Inc.**
