ARTICLES OF INCORPORATION OF REVEST! HOMES INC

Pursuant to the provisions of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned Incorporator, for the purposes of forming a Florida Profit Corporation, hereby adopts the following Articles of Organization:

ARTICLE 1 NAME

The name of the corporation is REVESTI HOMES INC, (the "Corporation").

ARTICLE 2 DURATION AND PLACE OF BUSINESS

The period of duration of the Corporation is perpetual and its principal place of business is at 6155 Elfin Herb Way. Winter Garden, FL 34787. 8.1. Any repeal or modification of the foregoing provisions of this Article 8 shall not adversely affect any right or protection of a director or agent of the Corporation existing at the time of such repeal or modification.
