ARTICLES OF INCORPORATION
OF
Early Trial Analytics, Inc.

The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, otherwise known as the "Florida Business Corporation Act," does hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation shall be **Early Trial Analytics, Inc.**

ARTICLE II
EFFECTIVE DATE OF INCORPORATION AND TERM OF EXISTENCE

The effective date of this incorporation shall be February 1, 2021. This Corporation shall have perpetual existence unless sooner dissolved according to law, and its existence shall commence on February 1, 2021 as reflected in the Certificate of Incorporation issued by the Secretary of State of Florida.

ARTICLE III
NATURE OF BUSINESS

The general purposes for which this Corporation is organized are the following:

- A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of this Corporation necessary or desirable in order to accomplish them.


