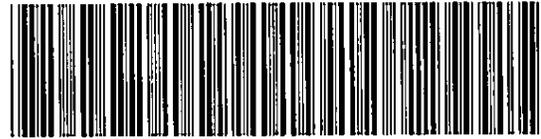

3. The professional association desires to amend Article III of the Articles of Incorporation. Accordingly, Article III of said Articles of Incorporation is hereby amended to read as follows:

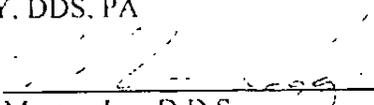
