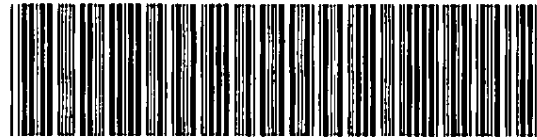

PURSUANT TO CHAPTER 607 FLORIDA BUSINESS CORPORATION ACT

M.O.B. Athletics, Inc., incorporated in the State of Florida on May 6, 2020, hereby amends and restates its Certificate of Incorporation as follows:

ARTICLE I.

The name of the Corporation shall be M.O.B. Athletics, Inc.

ARTICLE II.

The principal address of the Corporation is 7676-B Peters Road, Plantation, FL 33324. The address of the registered agent is 451 SW 59th Avenue, Plantation, FL 33317. The name of the registered agent of the Corporation at such address is Kayla Mobley.

ARTICLE III.

The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 607 of the Florida Business Corporation Act.

ARTICLE IV.

- A. The aggregate number of shares, which the Corporation shall have authority to issue, is one million (1,000,000) shares of common stock, par value one dollar (\$1.00) per share.
- B. Authority is hereby expressly granted to the Board of Directors (or a committee thereof, or one or more officers, or a board committee so authorized by the Board of Directors may authorize one or more officers) to designate the recipients of rights, options, or warrants or other equity compensation awards that involve the issuance of shares, and

determine within an amount and subject to any other limitations established by the board of directors, a board committee, and, if applicable, the shareholders, the number of such rights, options, warrants, or other equity compensation awards and the terms and conditions of such rights, options, warrants, or awards to be received by the recipients, provided that an officer may not use such authority to designate himself or herself or any other persons as the board of directors or a committee of the board may specify as a recipient of such rights, options, warrants, or other equity compensation awards, to the full extent now or hereby permitted by the laws of the State of Florida.

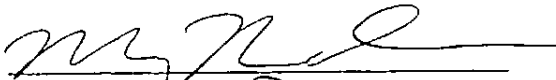
