ARTICLE I - NAME

The name of this corporation is SPACE COAST INVESTMENT MANAGEMENT, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolve in accordance with the laws of the State of Florida. Corporate existence shall commence at the time of filing of the Articles by the Department of State, State of Florida.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the operation of any and all lawful business permitted under the laws of the State of Florida and the United States of America.

ARTICLE IV - CAPITAL STOCK

This corporation is a closed corporation and authorized to issue only one class of shares of stock, designated "common stock", and the total number of shares which this corporation is authorized to issue is: 100,000, and shall be held on record by no more than 100 persons.

ARTICLE V - PREEMPTIVE RIGHTS

Every stockholder, upon the sale for cash of any stock of his corporation of the same kind, class or service, as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.

ARTICLE XIII - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law. And the liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permitted by law.

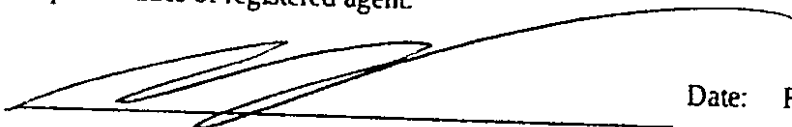
ARTICLE XIV - AMENDMENT

Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

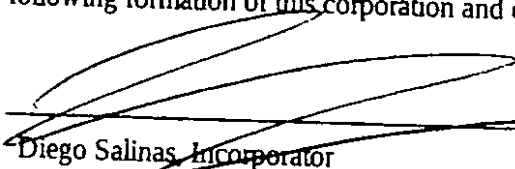
