The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I - Name**

The name of the corporation is **CR & RA HOLDING, INC.** (the "Corporation").

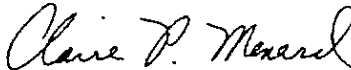
