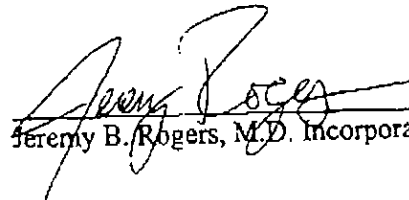
ARTICLE VII INDEMNIFICATION

ARTICLE VIII AMENDMENT

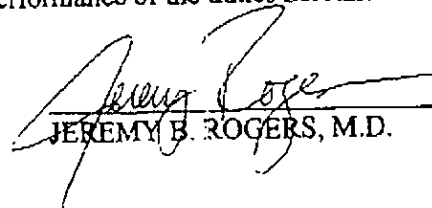
