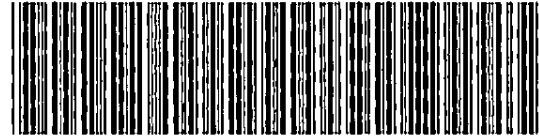

**ARTICLES OF INCORPORATION**

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I: NAME**

The name of the corporation shall be: **NORTH FLORIDA PRO WASH, INC.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 4511 Mountain Brook Lane East, Jacksonville, Florida, 32224.

**ARTICLE III: EXISTENCE AND DURATION**

This corporation shall exist perpetually commencing on February 24, 2021.

**ARTICLE IV: PURPOSE**





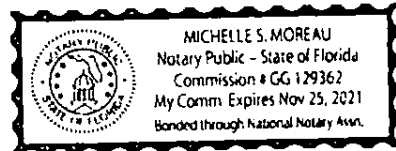
