In compliance with Chapter 607 and/or Chapter 621, Florida Statutes, the undersigned President of COASTAL PAINTING CONTRACTORS INC., a Florida corporation (the "Corporation"), hereby amends and restates the Articles of Incorporation of the Corporation filed on April 9, 2021, to read in its entirety as follows:

**ARTICLE 1**

**NAME**

The name of the Corporation shall be: Coastal Painting Contractors Inc. (the "Corporation").

**ARTICLE 2**
