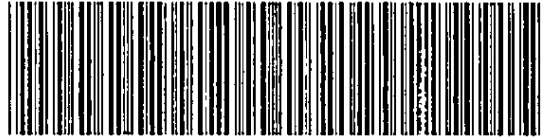

ARTICLES OF INCORPORATION

Coastal General Contractors Inc., a corporation organized and existing under the laws of the State of Florida, hereby certifies as follows:

1. The name of the corporation is Coastal General Contractors Inc. (the "Corporation"). The original Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on April 9, 2021. The Amended and Restated Articles of Incorporation were filed with the Secretary of State of the State of Florida on June 30, 2021, and the Amended and Restated Articles of Incorporation were amended by Articles of Amendment filed with the Secretary of State of the State of Florida on February 28, 2023.

2. These Second Amended and Restated Articles of Incorporation have been duly adopted pursuant to Section 607.1007 of the Florida Business Corporation Act of the State of Florida. The Corporation certifies that the amendments effected by this Second Amended and Restated Articles of Incorporation have been approved and adopted by written approval of the directors in accordance with Section 607.0821 of Florida Business Corporation Act and by resolution of the shareholders holding a majority of the outstanding shares entitled to vote on such amendment in accordance with Sections 607.0704 and 607.1003 of the Florida Business Corporation Act. The date of adoption of the Second Amended and Restated Articles of Incorporation by the shareholders is September 11, 2023.

3. The text of the Corporation's Articles of Incorporation as heretofore amended or supplemented is hereby restated and further amended to read in its entirety as follows:

**ARTICLE I**

The name of the corporation is COASTAL PAINTING CONTRACTORS INC.

**ARTICLE II**

The principal place of business and mailing address of the Corporation shall be 5660 Strand Court, Suite A18, Naples, Florida 34110.

**ARTICLE III**

The aggregate number of shares which the Corporation shall have authority to issue is 200 shares, no par value, all of which shall be common stock.

**ARTICLE IV**

The name and street address of the registered agent of the Corporation is HL Statutory Agent, Inc., 5811 Pelican Bay Boulevard, Suite 650, Naples, Florida 34108.

ARTICLE V

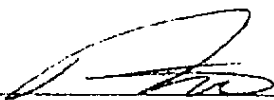
The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

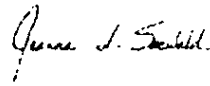
