**ARTICLES OF INCORPORATION
OF
NORTH TAMPA INDUSTRIES, INC.**

The undersigned, acting as incorporator of North Tampa Industries, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is North Tampa Industries, Inc.

ARTICLE II. ADDRESS

The street address of the corporation is 15614 Walden Avenue, Tampa, Florida 33618.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having no par value.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT
