ARTICLES OF INCORPORATION

OF

BRADLY LINENBERG, P.A.

I, Bradly Linenberg, the undersigned, who is licensed to practice the profession of real estate agent in the State of Florida, do hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

<u>ARTICLE I - NAME</u>

The name of this corporation shall be: BRADLY LINENBERG, P.A.

ARTICLE II - PURPOSE

The purposes for which this corporation is formed are:

- A. To engage in the practice of licensed real estate agent as a professional corporation and to carry on services incident thereto. The practice of licensed real estate agent is the sole and exclusive professional service to be rendered by this corporation.
- B. To own property, enter into contracts, and carry on any business necessary or incidental to the accomplishment or furtherance of the purpose or objects of this corporation.
- C. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been certified as a licensed real estate agent in the State of Florida.

ARTICLE III - CAPITAL STOCK

- A. The total number of shares of capital stock which the corporation shall be authorized to issue is One Thousand (1,000) shares. Such shares shall be of a single class of common stock and shall have a par value of \$1.00 per share.
- B. Each shareholder must be a duly licensed real estate agent in the State of Florida.
- C. No shareholder shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock.

ARTICLE IV - RESTRAINT ON ALIENATION OF SHARES

The shareholders of the professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. If any shareholder becomes legally disqualified to practice as a licensed real estate agent in the State of Florida, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

This corporation shall have perpetual existence commencing as of the date of execution of these Articles.
