ARTICLE IV CAPITAL STOCK

The aggregate number of shares of stock authorized to be issued by the Corporation shall

be one thousand (1,000) shares of common stock, of which five hundred (500) shares shall be

designated as "Class A Voting Common Stock," each with a par value of \$.001, and five

hundred (500) shares shall be designated as "Class B Non-Voting Common Stock," each with a

par value of \$.001. Each share of issued and outstanding Class A Voting Common Stock shall

entitle the holder thereof to fully participate in all shareholders meetings, to cast one vote on

each matter with respect to which shareholders have the rights to vote, and to share ratably in all

dividends and other distributions declared and paid with respect to the common stock, as well as

in the net assets of the Corporation upon liquidation or dissolution. The shares of the

Corporation's Class B Non-Voting Common Stock shall have all of the rights and privileges of

the Corporation's Class A Voting Common Stock, however, such shares shall not have voting

privileges.
