**ARTICLES OF INCORPORATION
OF
FREDERICK W. SHULER, M.D., P.A.**

The undersigned incorporator, for the purpose of forming a corporation in the State of Florida hereby adopts the following Articles of Incorporation.

**Article I
Name and Duration**

The name of this corporation is Frederick W. Shuler, M.D., P.A. ("Corporation"). The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

**Article II
Principal Office**

The address of the principal office and mailing address of the Corporation in the State of Florida is 1836 Florida Avenue, Panama City, Florida 32405.

**Article III
Capital Stock**

The maximum number of shares of stock which this Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares having no par value.

**Article IV
Registered Office and Agent**

The street address of the registered office of this Corporation is 1836 Florida Avenue, Panama City, Florida 32405 and the name of the registered agent of this Corporation at that address is Frederick W. Shuler, M.D.

**Article V
Directors**

The name and street address of the Incorporator of this Corporation is Frederick W. Shuler, M.D., 1836 Florida Avenue, Panama City, Florida 32405.


Article IX **Purpose**
