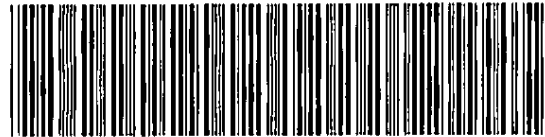

The name of the Corporation is: Salveo Technologies, Inc. The Articles of Incorporation were filed on May 6, 2021 under document Number P21000043570.


**ARTICLE II
