**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of the captioned professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this professional corporation is Danahy & Dunnavant, P.A., and its principal office and mailing address is 901 W. Swann Avenue, Tampa, Florida 33606.

**ARTICLE II**

**Commencement of Corporate Existence**

The professional corporation shall come into existence on the date of filing with the Florida Secretary of State.

**ARTICLE III**

**General Nature of Business**
