This Report was filed and signed without my knowledge or consent. I am not this company's registered agent and I did not sign or agree to sign the Report.
- 3. On April 25, 2023, Reciocorp Inc. filed its 2023 Annual Report (document number 6611561008CC) with the Department. Therein, it listed "Ittleman, Esq. Cams, Andrew S." of Fuerst Ittleman David & Joseph as its registered agent. The Report falsely bears my purported electronic signature.
