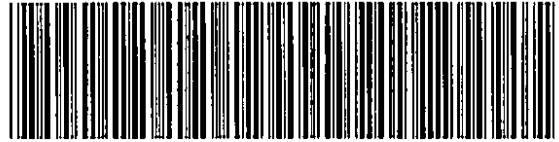

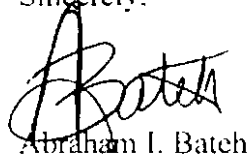

**ARTICLES OF INCORPORATION**  
**OF**  
**SK HORTON HOLDINGS, INC.**

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I. NAME**

The name of the corporation is SK HORTON HOLDINGS, INC.

**ARTICLE II. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation, and shall have perpetual existence.

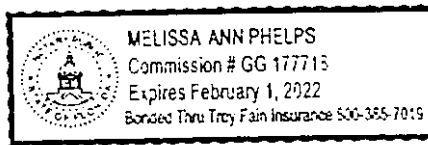
