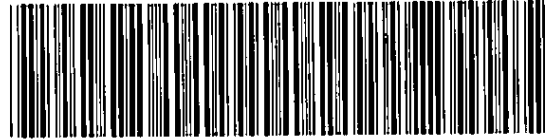

**ARTICLES OF INCORPORATION  
OF**

**KARD, CPA, P.A.**

The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice accounting under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, Chapters 621 and 607, Florida Statutes, and other laws of the State of Florida.

**ARTICLE I**

The name of the professional service corporation is: KARD, CPA, P.A.

**ARTICLE II**

The address of the principal office and the mailing address of the corporation is 120 S. Woodland Blvd., Suite 200, DeLand, Florida 32720.

**ARTICLE III**

This Corporation is organized for the following purposes:

- (a) To engage in every aspect of the practice of accounting and all of its fields of specialization as are engaged in by accounting firms in this state.
- (b) To engage and render the professional service involved only through its officers, agents and employees, who are accountants in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the professional service of this Corporation.
- (c) To invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments permitted by law.
- (d) To own real and personal property necessary for the rendering of professional services hereby authorized.

**ARTICLE IV**

The professional service corporation shall have perpetual existence starting on the date these Articles of Incorporation are filed with the Florida Department of State.

**ARTICLE V**

The capital stock of the professional service corporation shall be TEN THOUSAND (10,000) shares of common stock having a par value of TEN CENTS (\$.10) per share. None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice in the State of Florida.

## **ARTICLE VI**

The street address of the initial registered office of the professional service corporation is 120 S. Woodland Blvd., Suite 200, DeLand, Florida 32720. The name of the initial registered agent for the corporation at that address is Christopher Kard.

## **ARTICLE VII**

The business of the professional service corporation shall be managed by its board of directors. The initial board of directors shall consist of one (1) member. This number may be increased or decreased from time to time in accordance with the corporation's bylaws, but shall never be less than one.

## **ARTICLE VIII**

The name and address of the person who will serve on the initial board of directors is Christopher Kard, 120 S. Woodland Blvd., Suite 200, DeLand, Florida 32720.

## **ARTICLE IX**

The name and address of the person signing these Articles of Incorporation as subscriber is Christopher Kard, 120 S. Woodland Blvd., Suite 200, DeLand, Florida 32720.

## **ARTICLE X**

The professional service corporation reserves the right to amend or repeal any provisions in these Articles of Incorporation in the manner provided by law. Any right conferred upon the shareholders is subject to this reservation.

## **ARTICLE XI**

The shareholders of the professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions and details, of the disposition shall be determined by the shareholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock.

No shareholder of the professional services corporation may sell or transfer stock in the corporation except to another individual who is eligible to be a shareholder of the corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice accounting in the State of Florida or accepts employment that places restrictions or limitations on the continuous rendering of

rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the corporation in accordance with the bylaws adopted by the shareholders.

**ARTICLE XII**

Any action of the shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the shareholders entitled to vote upon such action at a meeting and filed with the secretary of the professional services corporation as part of the corporate records. If all of the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the secretary of the corporation, the action shall be valid as though it had been authorized at a meeting of the board of directors.

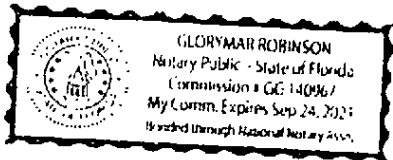
