## Attachment to Certificate of Incorporation of N-Rhythm Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 10000 of which 9000 shares of par value 1.00 per share shall be designated as Common Stock and 1000 shares of par value 1.00 shall be designated as Preferred Stock.
